

RELEASE AND WAIVER

By signing below, I acknowledge that all activities sponsored or conducted by Provo Canyon Outfitters (PCO) may be hazardous, and may result in accident, loss, damage, injury or death. I am aware that during any trip in which I am participating, certain substantial risks and dangers may occur, including but not limited to injury or death resulting from the hazards of traveling in rough river conditions. I understand that river running on a tube or raft or other watercraft poses numerous dangers and known and unknown risks inherent to the sport and that I am voluntarily participating with knowledge of such risks and dangers. I acknowledge that life vests are required on the river and PCO provides vests with each rental.

With full knowledge of the aforementioned dangers, and intending to be legally bound, I hereby agree for myself and on behalf of all of my family and heirs to RELEASE PCO, Deer Creek Park, any Utah or Federal agency or the Provo River Water Users Association, and any of its representatives, agents, directors, owners, employees, managers, coordinators, volunteers, fellow river runners from any and all liability, claims, demands or any causes of action, and NOT TO SUE OR OTHERWISE MAKE ANY CLAIM against any of the above mentioned entities or any of its representatives whatsoever which may arise during my participation in any activities I engage in which is involved with them or their services or activities, in or out of the river.

I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, expenses and costs, including but not limited to attorney's fees, incurred in connection with any claims brought as a result of my participation in PCO and Frazier Park activities which are released by the terms of this agreement.

I intend this RELEASE OF LIABILITY to be effective whether or not any accident, loss, damage, injury or death RESULTS FROM THE NEGLIGENCE of PCO, Deer Creek Park, any Utah or Federal agency or the Provo River Water Users Association, or any of its representatives, agents, directors, owners, employees, managers, coordinators, volunteers or fellow river runners. I understand that negligence means a failure to do an act which a reasonably prudent person would do, or the doing of an act which a reasonably prudent person would not do, under the same or similar circumstances, to protect himself or herself, or others, from accident, injury or death.

By signing below, I acknowledge that I have read and agree to the RENTAL AGREEMENT and I agree to be solely responsible for my own safety and to take every precaution to provide for my own safety and well-being while participating in activities sponsored or conducted by PCO and/or Frazier Park. This RELEASE AND WAIVER is given in the interest of permitting PCO and/or Frazier Park to exist and serve the river running community and to enable my fellow paddlers and river runners to feel free to donate our services and to help each other without fear of liability. My release is given in exchange for rental conditions and similar waivers to be granted on my behalf by others who use the services of PCO and/or Frazier Park. This RELEASE AND WAIVER has no expiration date.

PHOTOGRAPHY/VIDEO WAIVER: By participating in or attending any activity in connection with the program, whether on or off the premises, I consent to the use of any print or digital photographs, pictures, film, or videotape taken of me for publicity, promotion, television, websites, or any other use, and expressly waive any right of privacy, compensation, copyright or ownership right connected to same.

Policies

- Valid identification is required of all rental customers.
- Customers must be 18 years or older to rent equipment.

Procedures

- Provo Canyon Outfitters can be reached at (801) 225-5346.
- Customers must read and sign a Release and Waiver Form.

Deposit

- Deposits are required: we hold your valid Driver's License or open credit card.
- Rentals are for **up to 3 hours** – overtime charge are applied for rentals returned after 3 hours.
- Overtime charges of 50% of the rental price are incurred for every hour or portion thereof beyond 3 hours. Example: Tube Rental \$20. Price is \$20 for up to 180 mins. \$30 for 181-240 mins, \$40 for 241-300 mins.
- Equipment must be returned clean and in good repair.
- Fixable tears will be charged \$10 per inch on tubes and rafts, \$1 per inch on covers.
- Lost or damaged beyond repair will be charged full retail value – this includes flotation equipment and paddles.

Your Responsibility

There are inherent risks involved in the activities for which this equipment is to be used. You freely and voluntarily assume those risks, including the risk of serious injury or death. As with all outdoor adventure, you need to be prepared. You should have adequate river running clothing for whatever weather conditions you might encounter. . Life vests available at no charge with any rental. Consider your physical condition, weather conditions, time of day and your personal preparedness when considering what equipment you rent

Be safe, have fun and enjoy the natural beauty of the river and Canyon.
